## **Herpetology Camp**

This popular, weeklong nature camp has the inquisitive child in mind. Campers will explore the fascinating world of amphibians and reptiles side-by-side with herpetologist George L. Heinrich. Through up-close encounters with a variety of animals, such as gopher tortoises, frogs, lizards, and snakes, campers will learn about the ecology and conservation of amphibians and reptiles.

## **Wildlife Ecology Camp**

This weeklong summer camp is designed for children with a strong interest in nature. Campers will explore the ecology and conservation of Florida's wildlife and wildlands with field biologist and environmental educator George L. Heinrich. A blend of classroom and field sessions will include hands-on activities, guest presentations, and exploration of the preserve's diverse habitats, where campers will practice their nature detective skills.

## **Cancellation policy**

All cancellation requests must be received in writing via U.S. Postal Service or e-mail and be postmarked at least ten days prior to the start of camp. No refunds will be made for cancellations received after that date. A \$25.00 handling fee will be charged for all processed refunds.
